

# Admissions Checklist

- **Submit application by September 25, 2020, for Sibling Families or December 11, 2020, for New Families**

Priority will be given to applications received on or before the deadline which means we are able to guarantee the scheduling of appointments of Parent Interview and Child Visit. There are no guarantees we will have the ability to schedule families who submit an application past the December 11 deadline.

- **Tour the School**

Both parents (when applicable, even when living in separate households locally) are required to tour the School before the Parent Interview appointment. Separate tours may be attended. Reservations are required and are available online with our Inquiry Form.

- **Parent Interview**

Once an application has been submitted and parents have toured, the Admissions Office is able to schedule two appointments: one being the Parent Interview, the other the Child Visit. Both parents (when applicable, even when living in separate households locally) are required to attend the Parent Interview. Parents meet with the Director of Admissions for approximately 45 minutes to discuss their family's educational expectations and goals.

PARENT INTERVIEW DATE

- **Child Visit - Tentative for the 2020-2021 School Year**

This is a time for your child to try PS1 and participate in the daily life of the school. The Child Visit lasts an hour for 4-6 year olds and a half or full day for applicants ages 7 and above. Parents will get more exposure to the daily life of PS1. Specific Child Visit guidelines are shared with an applicant family ahead of the Child Visit appointment to ensure a great visit.
